### A Message From the President

As we look back on 2022, it was yet another challenging year as the complexities in addressing homelessness have only escalated. That said, Seacoast Family Promise (SFP) has navigated an aggressive plan to expand its current capacity in both transitional and permanent housing. In doing so, it makes 2023 a very exciting time as we evaluate all financial avenues including long-term third-party partnerships, Federal and State grant funding as well as you, our key stakeholders.

According to a recent report issued by the Department of Housing and Urban Development, an estimated 600,000 people experienced homelessness on a single night in January 2022. The surge in homelessness is seen from coast to coast. Specific to New Hampshire, approximately 2,000 people were experiencing homelessness during the same time period and an estimated 22% of them were unsheltered. The agency noted that the economic impact of the COVID-19 pandemic could have led to a far higher number if it wasn't for government outreach and programs to prevent eviction through rental assistance. However, the financial assistance programs have evaporated.

We know that New Hampshire has had a lack of affordable housing for decades. Years ago, most homelessness was dismissed as single adults with substance or mental health problems. Today, it's not that simple as families continue to add to the ranks. Rental costs have escalated, far outpacing renter incomes and many families are facing insecurity for the first time. In response, multiple plans have been presented, be it from the New Hampshire Charitable Foundation, the New Hampshire Council on Housing Stability, the Bureau of Homeless Services, and many others. There is reason for optimism.

During the height of the COVID-19 pandemic, SFP had to modify its housing model in acquiring properties to house our guests. Our largest acquisition was the Joshua House located in Greenland. Entering 2023, SFP has elected multiple paths to expand our capacity through 1) the expansion of the Joshua House which will almost double its capacity and 2) the possible partnership with municipalities for permanent shelter. Yes, more reason for optimism.

In closing, we have been extremely fortunate entering 2023 with many stakeholders, volunteers, and staff personnel to thank. The SFP Board of Director's have been an integral component of the expansion decision. My deep appreciation to all who made a difference, as it is a unique relationship. The new-year represents our 20th year and we refuse to rest on our past laurels. Your support and engagement has continued to enable SFP to help guide families home. It is our ardent hope that we can shepherd good hearts, intentions and efforts that will result in the eradication of child and family homelessness.


