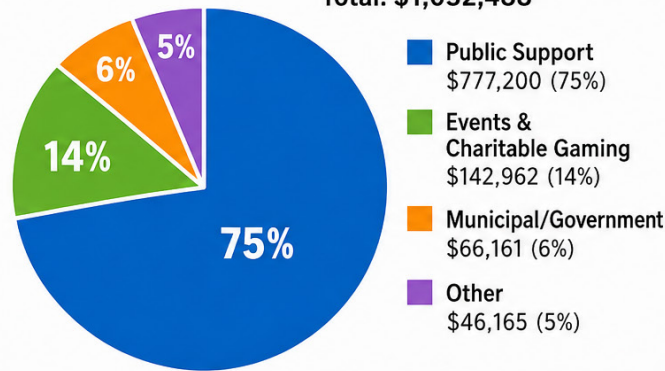

Finances 2024-2025

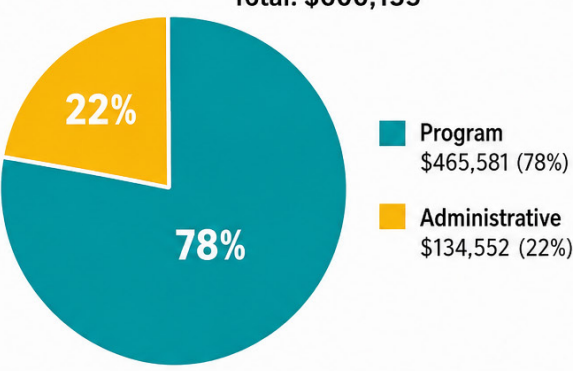
2024 REVENUE

Total: \$1,032,488



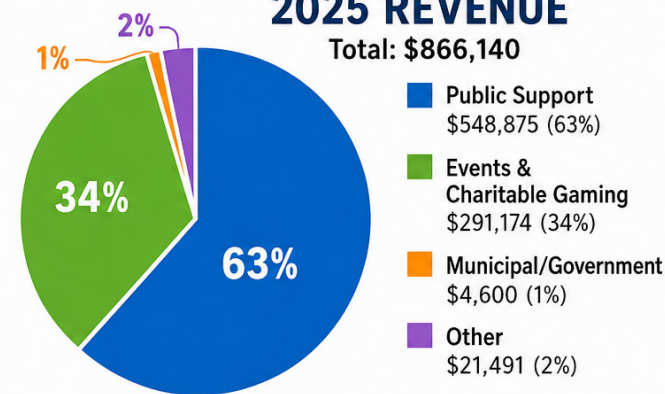
2024 EXPENSES

Total: \$600,133



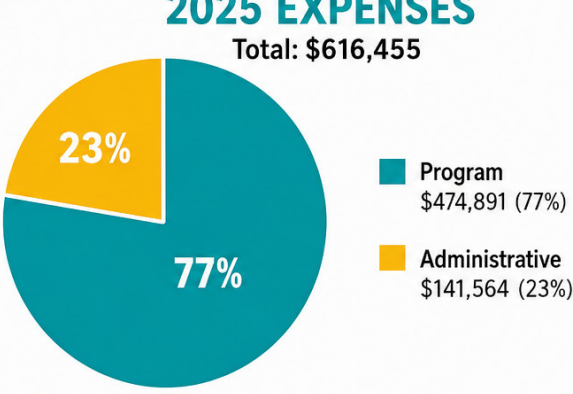
2025 REVENUE

FAMILIES SERVED IN 2025



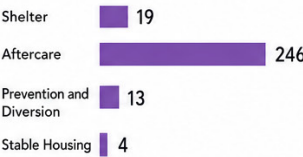
SFP CORE PROGRAMS (FAMILIES SERVED)

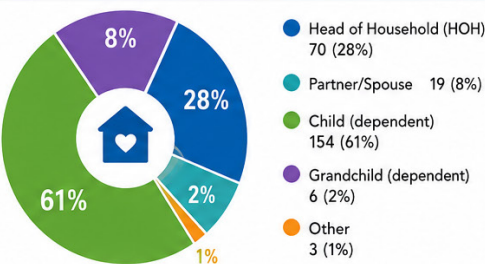

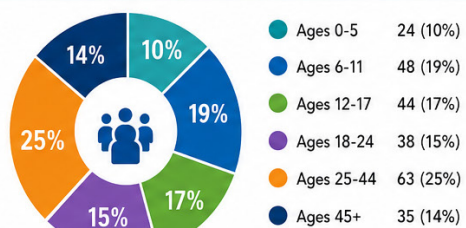
